

COOKIE USAGE POLICY

1. Que sont les cookies?

Cookies are small text files that can be used by websites to make the user experience more efficient, such as your choice of language. When you visit the website again, this cookie is sent back to the website, which recognises your browser and can, for example, remember your language choice.

Cookies generally also have an expiry date. Some cookies, for example, are automatically deleted when you close your browser (so-called 'session cookies'), while others remain on your computer for longer, sometimes even until you delete them manually (so-called 'permanent cookies').

2. Cookie management

3. What types of cookies are used?

When you visit this website, the following types of cookies are used:

A. Necessary cookies

A. Preference cookies

Preference cookies enable a website to remember information that modifies the way the site behaves or is displayed, such as your preferred language or the region in which you are located.

We do not use cookies of this type.

B. Statistical cookies

Statistical cookies help the website owners, by collecting and communicating information anonymously, to understand how visitors interact with the websites.

We do not use cookies of this type.

C. Marketing cookies

Marketing cookies are used to track visitors across websites. The aim is to display advertising that is relevant and interesting to the individual user and therefore more valuable to third-party publishers and advertisers.
